2.2	Question: In what phase is the District's current Capital Improvements Plan? How does this study align with development of the District's next Capital Improvements Plan? How will this process engage the ACPS staff responsible for developing the next Capital Improvements Plan?										
	Answer: The Fiscal Year 2019 Capital Improvements Plan (CIP) is complete and was approved by the Board of Education on September 12, 2017. Any recommendations resulting from this study may be considered during the development of future CIPs.

2.8 Question: It is unclear who is recommending the redistricting plan. Section I.A states that "the result of this study will provide information and recommendations to the Blue Ribbon Commission...related to the development of a redistricting plan." Section I.B states that the Blue Ribbon Commission will also provide information to the consultant so that the consultant may deliver a plan to recommend school attendance boundaries. Earlier in that same section, the RFP states that the Blue Ribbon Commission is formed to make recommendations to the school board and County Commissioners. There are many ways to approach this. The question is which approach is best for ACPS. Is the consultant recommending school attendance boundaries with the input of the Commission, or is the Commission making the recommendation with the consultant's guidance, support, and/or recommendation?

<u>Answer</u>: The best approach for ACPS is for the Blue Ribbon Commission to make the recommendation with the consultant's guidance, support, and/or recommendation.

2.9 Question: Section I.H identifies a timeline with a May 8, 2018 date for Board approval of recommendations and this study's final report. Does ACPS intend to implement a redistricting plan for the 2018-2019 school year?

<u>Answer</u>: ACPS does not anticipate any changes or implementation of a redistricting plan during the 2018-2019 school year.

2.10 Question: Section II includes the development of a public relations plan within the Scope of Services. Is the public relations plan intended to help the community understand the process for this study or does the timeline for the public relations plan extend into implementation of the redistricting recommendations? Will the consultant be a part of implementing the public relations plan during the implementation of the redistricting plan?

<u>Answer</u>: The public relation plan is intended to help the community understand the process for this study. The consultant will not be a part of the public relations plan during the actual implementation of the redistricting plan.

2.11 Question: Section III.C references a Work Plan activity for "assessing physical condition and educational adequacy of each building." Is a facility assessment a part of the scope of work for this utilization and redistricting study?

<u>Answer</u>: Yes, a facility assessment is a part of the scope of work for this utilization and redistricting study.

2.12 Question: The RFP appears to be silent on the question of MWBE participation in this study. Is there a minority or women owned business subcontractor requirement for this project?
