Allegany County Public Schools (ACPS) has received a number of requests for information regarding the flash flooding events of May 13, 2025. Below is a general timeline of events starting with the first flood watch issued by the National Weather Service on May 12, 2025, and until the last child was reunited with their parent/guardian on May 14, 2025. This timeline is not an exhaustive list of events but is intended to provide a summary of the events that occurred during the dates referenced. Not included are the over 300 phone conversations from the Incident Command Center established at ACPS Central Office to staff, as well as emergency personnel, during the natural disaster.

As indicated herein, the severity of the storm that caused the flash flooding was not forecasted or anticipated. Under the circumstances, forecasts did not warrant a school closure as of the evening of May 12, 2025 or the morning of May 13, 2025. Weather Watches (for snow, rain, tornadoes, high winds, etc.) are common and do not regularly result in school closures. All counties in the surrounding region opened school on May 13<sup>th</sup> on a regular schedule. The National Weather Services issued its flood warning after flooding began. Upon notification of flooding conditions, ACPS's only focus was on the safety of students and staff.

The Elected Board would like to note, that thanks to the efforts of ACPS staff and emergency services, no students or staff were lost or injured during what was later declared a State of Emergency.

8:58pm Frostburg City Police and additional School Security Employees arrive at

Mountain Ridge to help with reunification process
