"I really do appreciate the opportunity to take these kids to a national competition. What these kids have accomplished is something special. Caleb and Payton were in the top 10 nationally.

Caleb did job skill demonstration, taking a basic, entry level job skill. He did seizure protocol, where he went through what would happen if you were around an epileptic, how to take care of them, and what you would do in that situation. He demonstrated it for 5-7 mins in front of a group of judges.

Payton did welding sculpture, which started months ago. She took 8<sup>th</sup> out of 44 sculptures, which includes not only building the sculpture, but also presenting it. She learned the language and put together a book along the way, documenting everything from prices of materials to pictures of her doing each step."

#### **CEP (Community Eligibility Provision)**

 CEP is a Federal Program that is offered to low income counties to offer free breakfast and lunch to all of the students in Allegany County for the 2024-2025 school year

"We had been asking Mr. Blank, what could we do, but we were just at the point where financially it was just going to strap us. But I think COVID kind of brought to the forefront how dependent these kids were on school meals in the summer and the access they had at that time when it was funded. We hated to see all that go away. So this is fantastic, thank you for putting in for that. We hope the community is paying attention and realizes what a great thing this is."

### Instructional Update

#### **Summer School Update**

- Credit Recovery
  - Opportunity for students who have failed a class to recover it within a 20 day period
  - Offered three times during the school year, but also during the summer
  - Students can earn up to two credits back
  - Allows 9<sup>th</sup> graders to stay on track for college and career readiness requirements
  - A few changes were made this year
    - Stricter attendance policy students allowed 3 absences before being dismissed from the program
    - Each class had a set of assignments and it was required that all assignments be completed
  - 190 credits were recovered over the summer
    - 83.4% of the credits were higher than a D, as opposed to 22% of the credits last year
  - Almost double the amount of credits were recovered from students with IEPs
  - Three times the amount of credits were recovered from students with a 504
  - o 55 credits recovered by Freshman going into their 10<sup>th</sup> grade year
  - o Math, English, and Science were almost equal in credits recovered
- Original Credit
  - o Offering Physical Education, Health I, Health II, and Personal Finance
  - A total of 120 Original Credits earned across all courses
  - Most students take classes over the summer to help free up some time in the upcoming school year for dual enrollment, AP courses, sports, or other electives
