Program of Study

- Programs of study for the 2025-2026 school year
 - Center for Career and Technical Education (CCTE)
 - 14 different Career and Technical Programs at CCTE
 - o Agricultural Sciences and Operations Expansion
 - New course Agriculture Sciences and Operations Capstone
 Advanced Placement (AP) Preserver Evenencies
 - Advanced Placement (AP) Program Expansion
 - Will offer the Maryland AP Option, which requires students take 5 more AP courses in high school
 - Recognizes high school students who demonstrate exemplary college-level achievement on AP exams
 - Advanced Placement Pathways
 - Offers 3 pathways that will enable students to satisfy the Maryland AP Option: General, STEM, and Humanities
 - o Dual Enrollment Expansion Pilot
 - Expand dual enrollment opportunities to Grade 11 students who have met certain criteria – pilot through ACM
 - Spring scheduling timeline
 - February counselors visit classrooms and recruitment presentations
 - Late Feb / March Students select courses online via Aspen
 - March Meetings with students on their four-year plans
 - March Principals and counselors determine course offerings and staffing needs based on number of sections needed – schedule builds
