Superintendent's Report (cont.)

Transportation – Inclement Weather Procedures

- On days where inclement weather is possible, three transportation staff members check weather and road conditions
 - Check southern, eastern, and western parts of the county
 - Monitors weather conditions, road service conditions, road temperatures, and air temperatures and reports conditions to the supervisor.
 - Supervisor gathers information and checks weather forecasts on various media and internet sites, monitors radar for current and forecasts for later in the day.
 - Transportation office contacts County roads, ACPS Operations, local school bus contractors, and nearby counties.
- Time frame for delays and cancellations
 - A decision to delay or close school is pushed out to the public by 5:15am.
 - Information sent by messenger call, text, email, Facebook, and ACPS website
 - If a 2-hour delay is called, conditions will be re-evaluated and if conditions call for a closure, the decision is made by 7 am.
 - If a 3-hour delay is called, conditions will be re-evaluated and if conditions call for a closure, the decision is made by 8 am.
 - $\circ~$ Early dismissal decision due to weather will need to be made by 11 am.
- Do not have a bare road policy. Buses may travel on snow-covered roads to some extent. Bus drivers are instructed to pull off the road in a safe area and radio the office if they encounter roads that are difficult to travel.
- Cold temperature and wind chill policy
 - Of the ambient air temperature is a sustained zero or below, of the windchill is a sustained 15 or below, schools may be delayed or closed, depending on the projected forecast for that day.

Lockdown Updates

- Staff and students have been educated and have participated in the five emergency responses
- Materials have been placed in the schools, on the website, and also given to schools to be sent home with students at the beginning of the school year
- Currently working on a reference guide to be given to all ACPS administrators
 - Guide will provide valuable information on each emergency response, in detail
 - Guide will also provide sufficient information to refresh school faculty members at the beginning of each school year
