#### Introduce Allegany County Teacher of the Year

#### NEW BUSINESS

#### Consider Approving the Purchase of Furniture for New Allegany High School

The school board heard a presentation from Kieran Wilmes, partner at Grimm and Parker Architects, and Kerry Hill, senior associate at Grimm and Parker Architects, on the recommend furniture for the new Allegany High School. The selected furniture type was based on input provided by teachers, staff, and administrators through a survey developed by Grimm and Parker.

Samples of the classroom furniture were provided and evaluated by the staff and administrators. The selection of the furniture and purchase recommendations are based on expected durability, the preferences of staff, and cost. Additional furnishings, not available through a previously bid contract will be purchased separately. This will include some specialized furniture for the ALL science labs, shop equipment for technology labs, art rooms, and additional computer labs.

The contracts for the purchase of furniture total \$517,968.48. This purchase will be funded through an appropriation of the County's casino gaming funds and remaining construction contingency funds. Members voted to approve this purchase.

#### Consider Approving the 2018-2019 Academic Calendar

The school board voted to approve the 2018-2019 academic calendar. The calendar can be viewed on the school system's website at <a href="https://www.acpsmd.org">www.acpsmd.org</a>.

#### Consider Approving the Health Care Management Bids

The school board approved renewing three and four year contracts with the school system's current providers — Cigna, Delta Dental, and NVA. After reviewing RFPs from several other providers, it was recommended by staff and a third party administrator to continue with the current providers.

Consider Approving Request for a Post-Labor Day Waiver from MSDE The school board voted to approve the request by Dr. Cox to submit a waiver to the Maryland State Department of Education for a post Labor Day start for the 2018-2019 school year.

#### Consider First Reading of Policy for Board Meetings (File: BE)

The school board approved the first reading of the above policy, whose purpose is "to establish guidelines for conducting business, receiving and/or discussing matters of concern, and providing an opportunity for citizens to voice opinions or identify problems in an orderly and efficient manner."

### Consider First Reading of Policy for Student Financial Obligations (File: JN)

The school board approved the first reading of the above policy, which states, "Students who have lost, damaged, or destroyed textbooks or library books, equipment or other school property are to be responsible and

Consider the Second Reading of Policy for Federal Awards and Grants (File: **DDC)** The school board approved the second reading of the above policy, whose purpose states, "The Super Circular has imposed a duty on a recipient of federal awards to establish written procedures to comply with federal requirements in order to receive federal awards. As to all federal awards, Allegany County Public Schools is required to establish written procedures for 1) administration of funds; 2) determining the allowability of costs; 3) regulating procurement; and 4) identifying and avoiding conflicts of interest.

accountable for such items. The student may be charged a reasonable amount for such damage or loss, with consideration for the age and condition of the items. Students who do not satisfy financial obligations owed to ACPS may be denied certain privileges including but not limited to participating in graduation ceremonies."

## Consider Repealing Policy for Grouping for Instruction (File: IHA)

The school board voted to repeal the above policy from 1993 that stated, "Children will be grouped for instruction within a school and within a classroom so that each child may learn to a greater extent than otherwise possible."
