# Math and Statistics Awareness Month and Recognition of ACPS Accomplishments in MathCounts

The school board recognized Braddock and Mt. Savage Middle Schools for their accomplishments in the 2020 MathCounts district competition. Braddock Middle School 's team placed  $1^{st}$  for the  $8^{th}$  consecutive year and their  $29^{th}$  championship in 37 years, and was also a State Qualifier. Mt. Savage Middle School's team placed  $2^{nd}$  and was a State Qualifier.

The following Braddock team members were recognized for their achievements: Colin Sheehe -1<sup>st</sup> place overall for the 3<sup>rd</sup> consecutive year; Emmanuel Kujenga -3<sup>rd</sup> place overall; Sam Yu and Nathan Peterson.

#### Present Proclamation Recognizing April as Library Media Month

The school board presented a proclamation recognizing April as Library Media Month. The library media program is to ensure that students and staff are effective users of ideas and information. The role of the library media specialist is to provide the leadership and expertise necessary to ensure that the program is an integral part of the instructional program of the school. Library media specialists teach the skills of locating and using information through traditional resources and new technologies, to provide literature appreciation activities, and to guide and encourage content and recreational reading to every student.

#### Recognition of Carson Scholars

The school board recognized several students who were named as 2020 Carson Scholars in recognition of their outstanding academic achievements with GPAs of at least 3.75 and their humanitarian qualities. Preston Crawford, fifth grader at Flintstone Elementary School, was honored as a first time scholar. Repeat recipients were as follows: Cameron Breighner, Mt. Savage 6<sup>th</sup> grade; Kelsey Darber, Washington 8<sup>th</sup> grade; Kinsey Hostetler, Braddock 8<sup>th</sup> grade; Robert Moffett, Allegany 10<sup>th</sup> grade; Brooklyne Noel, Fort Hill 10<sup>th</sup> grade; Dawson Ternent, Mountain Ridge 11<sup>th</sup> grade; and Benjamin Twigg, Washington 8<sup>th</sup> grade.

The Carson Scholars Fund awards \$1,000 college scholarships to students in grades 4-11 who excel academically and are dedicated to serving their communities. Previous winners of Carson Scholarships are eligible to reapply for Carson Scholar recognition. An interested student must be nominated by an educator at his or her school to be able to compete for a Carson Scholarship. Scholarships are awarded solely on the basis of academic achievement and humanitarian qualities.

## INSTRUCTIONAL UPDATES

#### Continuity of Learning and Special Education Plan

Dr. Kim Kalbaugh, ACPS Chief Academic Officer, updated the school board on the system's continuity of learning and special education plans. Continuity of learning is a process by which learning continues through the delivery of standards-based activities and assignments that can be completed with limited instruction. MSDE has provided guidance for content areas. ACPS is providing continuity of learning through online platforms including Class Dojo and Google Classroom and through learning packets, which are distributed every two weeks at each school. Statistics from the last two weeks show an increase in students utilizing online platforms (from 65% to 73%). Additionally, engagement increased from 95% to 99% in the district. Administrators will maintain updated statistics each week.

Every special education student was contacted to develop an individualized continuity of learning plan that addressed their current IEP goals and supports and how they would be delivered during this period of remote instruction. Individualized resources to support instruction are provided to students either through an online format or on paper. The special education teacher and/or related service provider provide support either by phone, online, or on paper, or in some combination as identified by the student's individualized continuity of learning plan. Special Education Facilitators (SEFs) lead virtual meetings to develop individualized continuity of learning plans (ICLP). Special education teachers and related service staff provide remote services per the ICLP, and they collaborate with parents on data collection. ICLPs are modified and adapted to meet student and family needs. Virtual professional development activities were conducted with SEFs and school psychologists on how to conduct meetings remotely and develop and ICLP. SEFs and school psychologists led over 1,300 virtual meetings with teachers, service staff and parents to develop ICLPs based on current IEPs. In addition to creating a framework for conducting remote meetings and developing an ICLP, the special education department has developed a system to facilitate the digital signing and submission of Medicaid forms and billing remotely. When ACPS resumes a normal schedule, SEFs will conduct meetings with families and educational teams to determine student progress and if there is a need for additional services as a result of building closures.

ACPS continues to provide links, resources and supplemental activities for students and parents during the COVID-19 pandemic. A crisis management website has been established as well as an IT Help Desk and Community Help Desk for staff and parents/students to address technical issues. School counseling, mental health, IEP services, pupil service teams, and principal and supervisors all continue to conduct weekly meetings to address important issues. Tutoring services, an academic help desk, and Chromebook and mobile hotspots are also currently being discussed and/or developed.

#### Other Instructional Updates

Dr. Kalbaugh also provided scheduling updates. Middle and high school schedule builds were completed for all schools. All middle schools will have social studies and science every day. Additionally, the Agricultural Science electives will be taught at all three comprehensive high schools in the fall of 2020. They include Intro to Agricultural and Natural Resources and Wildlife and Forest Management. Twenty-five 9<sup>th</sup> grade students are in the 2020-2021 P-TECH cohort with seven on a wait list. Melissa Kaye, P-TECH Coordinator, has conducted phone or videoconferences with all students and parents/guardians. Of these 25 students, three plan to complete the four-year pathway and 22 plan to complete the five-year pathway. In 2020-2021, ACPS will have four P-TECH cohorts, with the first one entering 12<sup>th</sup> grade. Two students are anticipated to graduate from high school and ACM in May of 2021. Overall, the P-TECH students have taken a combined total of 52 college courses this year. The students have an overall GPA of 3.3 while participating in a variety of sports, chorus/band, and various clubs. During this school closure, Ms. Kaye is closely monitoring P-TECH student progress. For the 2020-2021 school year, enrollment at the Career Center increased to 145 juniors and 124 seniors. The CCTE will also be offering college speech, college English, college probability and statistics, with enrollment increases in trig/pre-calculus, AP Language, and Honors English III.

The State Superintendent of schools, pursuant to the jurisdiction of the State board, may waive up to five days of student attendance form Maryland public schools for the 2019-2020 school year, upon the request of the local superintendent of schools. Per the State BOE meeting, there will be waivers for seniors regarding state assessment requirements, Bridge, and service-learning hours. ACPS will request to use the minimum graduation requirements of 21 credits by the MSDE for seniors. In addition, ACPS received high school winter government scores, which will be available in Aspen in the near future. The field test for grade 8 U.S. History will be postponed until May of 2021.

#### **NEW BUSINESS**

Consider Approval of Requesting a Waiver from the MSDE State Superintendent The school board approved a motion for Mr. Blank to send a letter to request to the Maryland State Superintendent of Schools to waive five student days from the 180-day required minimum number of school days.

## Consider Approval of Temporarily Waiving ACBOE Policy to Comply with State Board Decisions

The school board approved a motion to waive Allegany County BOE policies as deemed necessary to comply with MSDE decisions during the COVID-19 pandemic.

#### Vote to Meet in Executive Session May 12, 2020, as Necessary

The school board voted to meet in Executive Session on Tuesday, May 12, 2020, pending any appeals or unfinished business. All meetings will continue to be held virtually until further notice. #### SPECIAL REPORTS AND BOARD MEMBER COMMENTS

#### Mrs. Tammy Fraley

Mrs. Fraley has been a part of several virtual calls with Senators regarding the need for better broadband in Allegany County. They are aware of our concerns. She noted that while she understands that virtual learning has been difficult during this time, she appreciates the work that ACPS mental health groups are doing to provide helpful resources to students, staff and the community. She also appreciates the work that teachers have done to help keep their students connected with each other.

#### Dr. Edward Root

Dr. Ed Root shared that he had a recent conversation with MSDE, Dr. Karen Salmon, to gather suggestions from local districts in the event that Maryland public schools re-open this school year. He mentioned that he suggested that one possible option could be to go back on a class by class basis and have half of the students in a classroom go to school one day and the other half of the class go on the next day. This option was for alternating full days of school, not half days. Dr. Salmon was accepting suggestions but it does not mean that those suggestions are now being considered. Dr. Root also stressed to Dr. Salmon that if schools do re-open this year, any parent who feels unsafe or uncomfortable sending their student back should not be penalized for choosing to keep them home and continuing with remote learning. He also noted that any decision to re-open schools will not be made at the local level. This decision will be made at the state level, when and if circumstances permit under conditions that are felt to be safe for all students and staff.
