Mr. Blank also specifically recognized and thanked three administrators he's had the pleasure of working closely with for several years, Dr. George Brown, Mrs. Kim Smith, and Mr. Martin Crump.

Summer School Update

Mr. Blank provided the school board with an update on summer school participation. ACPS will offer three sessions of elementary summer learning camps, and to date, there are 769 students registered for Session 1; 760 students registered for Session II; and 693 students registered for Session III. At the middle school level, 179 students are registered to participate in the compensatory program at Braddock Middle School. Other sessions of middle school programs include 97 students registered for Session I and 70 students registered for Session II. Additionally, 195 students will participate in Credit Recovery Summer School at Allegany High School.

NEW BUSINESS

Consider Approval of FY 2022 Operating Budget

Mr. Larry McKenzie, ACPS Chief Finance Officer, updated the school board on the FY 2022 Operating Budget. He noted that there has been one major change, from a budgetary standpoint, from what was previously submitted to the county compared to date. In the interim, MSDE's calculation for maintenance of effort changed dramatically. Now, it does not take into account the September 30, 2020, enrollment count, which was artificially deflated as a result of COVID. Instead, the calculation is now based upon the average of the three most recent years, excluding 2020. As a result, the county's maintenance of effort obligation was increased to \$31,854,912, which is an increase of \$716,242 from the original budget request.

As Mr. McKenzie previously shared, budgeted revenues and expenses for the district must match, so in order to balance the budget with the additional revenue, he recommended the following changes:

- Reduce to \$0 the \$400,000 that was to come from fund balance to balance the original budget request, which would leave \$316,242 in additional revenues.
- Use the additional revenues with Capital Outlays for Capital projects within the district.

The school board voted 3-2 to approve the FY 2022 Operating Budget.

Consider Approval of Special Education Staffing Plan FY 2022

Mrs. Debbie Metheny, ACPS Supervisor of Special Education, updated the school board on the FY 2022 Special Education Staffing Plan. The plan was developed with the goals and objectives of the Allegany County Master Plan in mind, and the components have been publicly discussed as part of the budgetary process. Allegany County's local application for federal funds in the amount of \$2,502,008 was funded by MSDE for FY 2021. Infant and Toddler funds in the amount of \$224,939 was also funded in FY 2021.

Staffing decisions for the 2021-2022 school year were made through a series of meetings during which special education administrators, facilitators, and staff looked at student data and identified IEP needs. Assignment of staff

was based on student needs. The Special Education Department will employ, using local and restricted funding, the following providers at the beginning of the school year:

- 87.4 teaching positions
- 92 full-time instructional assistants
- 30 part-time instructional assistants
- 27.4 professional positions (audiology, speech and assistant, vision, interpreter, hearing, mental health coordinator, school psychologists)
- 24.2 professional positions (infant and toddlers coordinator, facilitators, behavior specialists, nonpublic, assistive technology/data management, instructional specialists, itinerant autism specialist)

Changes affecting caseload and staffing throughout the school year requires flexibility in regards to staffing. These changes are necessary to implement the IEPs of students with disabilities in the least restrictive environment to provide a free and appropriate public education. The staffing plan will be reviewed at monthly staffing meetings and quarterly Special Education Citizens' Advisory Committee Meetings.

The school board voted unanimously to approve the FY 2022 Special Education Staffing Plan.

Consider Approval of Bid for OT/PT Services Contract for School Year 2021-2022

Allegany County provides occupational therapy and physical therapy to students in accordance with IDEA, COMAR, and the Americans with Disabilities Act and Section 504. Occupational therapy and physical therapy are provided in accordance with a student's IEP, IFSP, or 504 plan. The winning FY 2021 OT/PT bid would be subject to renewal at ACPS discretion for one academic year. The school board, at the recommendation of Mrs. Debbie Metheny, approved the FY 2021 winning bid from School Therapy Services and voted to renew this bid for the FY 2022 year.

Consider First Reading of Attendance Policy (File: JED)

The school board approved the first reading of the above policy, whose purpose is "to define the school system student attendance policy." The policy states, "Regular

school attendance is expected of all students in ACPS. School attendance is directly related to school achievement. In order to maximize academic achievement, there must be a unified effort by all school staff, parents, students, and the community to improve overall school attendance. School administrators, teachers, and support staff are expected to make all reasonable attempts to assist students and parents in addressing those factors which cause students to be absent from school."

Regulations and Exhibit Review for Attendance Policy (File: JED-R, JED-E1)

The school board reviewed the above regulations and exhibit for the Attendance Policy. There was one notable change that was made to be in compliance with the Maryland Students Records System Manual.

Regulations and Exhibit Review for School Attendance Areas Policy (File: JC-R, JC-E1)

The school board reviewed the above regulations and exhibit for the Attendance Areas Policy. There was one notable change that was made in order to eliminate an ambiguity in the process for the renewal of out of district permits.

Exhibit Review for Student Data Privacy Policy (File: JRA-E2)

The school board reviewed the above exhibit for the Student Data Privacy Policy. ACPS provides students with access to online educational services for use according to the requirements for participation in an ACPS instructional program and may be provided with equipment from ACPS. Each year, the online educational services agreement must be signed by the student and parent/guardian and then returned to the teacher before access to the online educational services is permitted or the equipment/online educational services can be issued. Approved online services are listed on the ACPS website.

Approval of the Superintendent's Contract

The school board voted unanimously to approve a four-year contract for Mr. Jeff Blank as the Superintendent of Schools.
