



Instructional Report

Academic School Calendar – Virtual Day Plan

- First Day for teachers would be August 16, 2023
- School would open pre-labor day on August 23, 2023
- Proposing a staggered start for Pre-K and Kindergarten
 - Allow teachers to set practices and routines with a small group of students in both AM and PM
- Regularly scheduled days / delays scheduled
 - Parent conferences for Fall and Spring term
 - Primary Election day in April
 - Thanksgiving, Christmas, and Easter breaks
 - Supervisor staff development and teacher work time
- Last day for students without any built in days is May 30
 - Last day with built in days would be June 6
 - Teachers would get out before June, without any built in days
- Requesting to use 3 asynchronous days and up to 5 synchronous days for inclement weather
 - 3 asynchronous days students will log on to Schoology and complete lessons after 9:30am
 - 5 synchronous days will be used as real time learning with a teacher





Instructional Report

New Dual Enrollment Program

- ACPS and ACM have been awarded a joint MSDE grant (Maryland Leads)
 - Develop a one-time, teacher education early college program
 - Allow ACPS high school students to begin working towards associate degree in teacher education
 - Incoming juniors and seniors interested in all areas of teaching are encouraged to apply
 - Program offers:
 - FREE tuition for early college courses
 - FREE early college textbooks and course materials
 - FREE laptop
 - Fast-track towards obtaining teacher certification
 - Eligibility is based on GPA
- ACPS to partner with FSU on Dual Enrollment Pilot Bobcat Academy
 - Give motivated high school seniors an immersive college experience and opportunity to earn college credits while also completing their final high school requirements
 - o All classes offered on FSU campus
 - Students will have a full-time schedule of 12-18 credits
 - Four pathways offered:
 - Exercise and Sports Science
 - Psychology
 - Environmental Science
 - Recreation and Parks Management
 - Studies will fall under general studies, so the student can use credit hours regardless of what major they ultimately decide on
 - o Students can continue to play sports for their home school
 - Eligibility based on GPA

Financial Update

Superintendent's Operating Budget

- Priorities
 - Modernize current student programs, associated equipment, and curriculum needs for current and future CCTE programs
 - Provide educational recovery programs through school year and summer
 - Maintain and enhance student safety and mental health
 - Provide employees with negotiated benefits including salary and health insurance
 - o Maintain and enhance resources and programs for early childhood development



Superintendent's Operating Budget

- Personnel
 - o Meet the contractual obligations previously set forth with all bargaining units
 - o Provide personnel to support the Blueprint Pre-K initiatives
 - Provide additional administrative position to support education programs
 - o Fund 4 additional LAP Instructional Assistant positions within elementary
 - $\circ~$ Fund 3 additional special education positions to assist with needs in infant / toddler
 - Provide 2 transportation positions to support bus driver training / development
 - \circ $\;$ Hire additional school security officers
- Non-Personnel
 - Transportation costs decreasing
 - o Increased bank fees to support increase in interest revenue
 - Provide additional funding for increasing utility costs
 - o Provide support for increasing health claims and other fixed charges
 - o Increased level of athletic transportation
 - Appropriate funding for staff development opportunities
